Report on day's events:

- Early Judges scratches (other) of FCEE N and MCJAGERSONTHEMOVE from the fifth race; both horses were claimed after entry and the new owners declined to start today.
- Program correction for DREAMFAIR TECATE in the sixth race; this horse was trained by Yves Tessier at time of entry.

- 1. Discussed race pace with the driver of #6 PLAYIN FOR KEEPS, Marc St. Louis, concerning the second quarter (27² 58); the explanation of Mr. St. Louis that this horse faded (finished fifth) was accepted and no regulatory action is required. Clear.
