Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Early Vet scratches (sick) of RADAR ENFORCED from the second race, SOUTHWIND BROWN from the sixth race and STORMY BEACHGIRL from the seventh race: these horses are entered on the short term (seven days) veterinary list.
- Spoke with the trainer (Yves Tessier) and driver (Pascal Berube) of NATIONAL DEBT regarding past performances.

Races:

- 1. Both #4 WARRAWEE VULCAN (Stephane Pouliot) and #5 BOSTON BLUE (Robbie Robinson) were off the starting gate at the start; the starter reviewed the start with both drivers and accepted their explanations but will require these horses to be on the starting gate in future. Clear.
- 2. Reviewed the performance of #1 SHOTGUN JERRY (Stephane Pouliot) regarding the second quarter (28³ 100² 127⁴ 157¹); this was a two year old maiden class and Mr. Pouliot did not cause any confusion or hinder the trailing horses while cutting the mile, no regulatory action required. Clear.

Inquiry on the performance of #1 FIERCE MAGIC (Guy Gagnon) who broke after the start, stretch and finish and was lapped on by two horses at the finish; #1 finished 4th placed 6th for the lapped on break and failure to continuously lose ground while off stride (AGCO rule 22.27). This horse was examined by the AGCO veterinarian post race and placed on the long term vet list (lame) and must qualify (trainer notified). Clear.
