

5. Inquiry on the performance of #5 NIGHT CLUB HANOVER (Richard Simard) who broke at the top of the stretch and while off stride did cause interference to all other horses in the race; #5 finished third and was placed ninth (last) for causing interference to the field (AGCO rule 22.09).

6. Inquiry on the performance of #2 JAZZ BEACH (Rodney LaFramboise) who broke before the start and had not reached the fair start pole when the starter released the field; full parimutuel refund: \$10,071 (AGCO rule 22.03(I)). Clear.
