Report on day's events:

Office:

- Discussed the scratch of SILVERADO from the seventh race on 17 October with the Paddock Judge, Ernie O'Dwyer, and the trainer, Wayne Laviolette. This horse was a veterinary scratch (sick), which the trainer claims was incorrect as his trailer had a flat tire and the scratch was due to transportation issues. This horse is entered for Sunday 28 October, and Mr. Laviolette is required to produce documentation to support the transportation scratch prior to the race.
- Early veterinary scratches (sick) of WISH KEY K from the second race and PAM AND LAURA from the sixth race; both horses are entered on the short term (seven days) veterinarians list.
- Virtual review held with driver Drew Smyth concerning his urging of WOO SHARK in the seventh race on 17 October; Mr. Smyth is now fully aware of what is acceptable, and unacceptable, urging, and the penalty structure for violations of the urging rules, and will modify his driving technique to remain in compliance for all future races; official warning entered on the licence of Mr. Smyth pertaining to this review.
