#### Office:

- Early Veterinary scratches (sick) of VILLAGE JAMIE from the fourth race and FARMERWHOSEMYDADDY from the ninth race; these horses are entered on the short term (seven days) veterinarians list.
- Virtual review held with the trainer of TWIN B SUNKISSED, Francis Dumouchel, concerning the cobalt overage (quantified at 134 ng/mL) of this horse from the fifth race at Rideau Carleton on 22 August 2021. Mr. Dumouchel is adjudged guilty of violating AGCO rules 9.09(a), 26.02.01, 26.02.02 and 26.02.03(c); a settlement agreement has been proffered to Mr. Dumouchel.
- Complaint received from the test barn regarding the conduct of two individuals; the panel will contact these individuals to discuss conduct on the next race date.

- 4. Driver of #3 ARRHYTHMOGENIC, Daniel St. Pierre, was adjudged guilty of violating AGCO rules 22.23.01(b) (excessive) and 22.23.03(b) (more than acceptable wrist

action) and assessed a driving suspension of five days (1-5 November, inclusive) and a monetary penalty of \$300 (second violation within a period of one year) (Number 1504531). Clear.

- 5. Driver of #1 KOLOY DM, Ryan Guy, was cautioned regarding his urging in the stretch. Clear.
- 6. Inquiry and driver's objection concerning possible interference by the race winner #1 TIME TO DANCING (Guy Gagnon) on #2 BONITAS SUNSHINE (Stephane Pouliot), who finished eighth, before the ¾ mile pole; #1 broke before the ¾ mile pole and while off stride did cause interference to #2 (charted with an interference break), #5 BET ON A DREAM (Clarke Steacy) and #7 CHUCK THE CHEESE (Stephane Brosseau); objection upheld; #1 finished first placed eighth for causing interference while off stride (AGCO rule 22.09). Clear.

This race declared no contest (AGCO rule 22.32.02). Before the ½ mile pole #4 LIL MOE MONEY (Ryan Guy) went sideways (locked on left line) and hooked wheels with #5 RED JOHN (Samuel Fillion) resulting in contact with #6 BET TILL DAWN (Mike Healey); both Ryan Guy and Samuel Fillion were unseated with #4 and #5 running loose (both horses were examined by the AGCO veterinarian with #5 determined to be uninjured and #4 placed on the long term veterinarians list); the warning lights and siren were activated declaring the race no contest. Both Mr. Guy and Mr. Fillion were uninjured. Mr. Fillion was excused from his remaining three drives.

Cancellation fees will be paid to all starters (Number 1504608).

Reviewed racing after the ¾ mile pole; #2 BATTLE WITH DESIRE (Marie-Claude Auger) decelerated and, while backing through the field, hooked wheels with #7 SPORT A LUCKY STAR (Mike Healey) who was charted with interference; #2 finished last (distanced) and qualifies for performance (trainer notified). Clear.
