

Judges issued AGCO ruling #1517104. Don Rankin did use more than acceptable wrist action while urging "Ken Kan Win" in race #5 on November 5, 2021 (Second offence within a year). Mr. Rankin issued a \$300.00 monetary penalty and five-day driving suspension November 10,11,12,13,14, 2021.

Races:

Race #1 - "Inquiry" prior to the start #5 "Liminary Hanover" (Goddard 8th) makes a break in stride prior to the start and was outside the fair start pole, refunded. (\$1043). https://youtu.be/TQwba92xXf8 #5 placed on the Judges List and must qualify for breaks (2 in a row fast track)

#1 "Mr. Arch" (Rooney 6th) makes a break in stride prior to the start, #8 "Wynd Creek" was not interfered with, as he was well back and behind #2.

Race #4 -. Reviewed racing after the ½ #8 "Smilingbillythekid" (M. St Louis 7th disqualified) does come down and interferes with the front legs of #7 "Chappiesboy" (T. Borth DNF), causing him to fall to the racetrack. Borth was uninjured.
