#### TERMS AND CONDITIONS 2011 – ASHA YEARLING SALE

The following policies and options for consignors are in effect and will apply to the ASHA yearling sale to be conducted on Saturday, September 24, 2011 at Olds Agricultural Society, the Megadome building. It is the consignor's responsibility to be aware of these policies and practices. Information and clarification is available by contacting the ASHA office in Calgary.

In entering a horse in this Sale of **ALBERTA STANDARDBRED HORSE ASSOCIATION**, the Consignor agrees to the following:

- 1. The yearling must be tattooed or freeze branded.
- 2. A negative coggins test dated no more than (60) sixty days prior to the Sale MUST be in the Sales Office.
- 3. Registration Papers and a signed transfer MUST be in the Sales Office. With respect to yearlings electronically registered, please provide the sales office with a signed transfer.
- 4. Minimum Bid- Opening bids lower than \$1000 will not be accepted with the exception of the 4-H consignment. (4-H yearlings must sell)
- 5. ASHA SALES COMMISSION: \$100.00 or 5% whichever is greater (Plus GST).
- 6. A Withdrawal Policy will be in effect for the 2011 sale. Yearlings withdrawn from the sale after the consignor has received the consignor's sale package, may only be withdrawn from the sale with a certificate issued by an ASHA assigned veterinarian.
- 7. A Reserve Bid Procedure will be available for the 2011 sale. Consignors should familiarize themselves with this selling option as it contains some restrictions on consignor bidding after the reserve price has been reached in the sale ring.
