



## APPLICATION FOR ONTARIO APPRENTICE TRAINER

This application must be completed by Ontario residents applying for an "A" or "F" trainer licence for the first time or by those applying for an upgrade from an "F" to an "A" trainer licence OR those who have failed to renew their trainer licence in the prior year. Please note that licensing fees are prorated in accordance with the Standardbred Canada birth date renewal system relative to the date the licence is approved to the applicant's birth date.

<ul> <li>"A" Trainer licence will permit you to operate a public stable at all extended and non-extended meetings. The first time applicant for an "A" licence:</li> <li>1. must have attained 16 years of age;</li> <li>2. must file a recommendation from the panel of regional judges to write the examination;</li> <li>3. must achieve a passing grade of 75% on the written trainer examination;</li> <li>4. have a minimum of four (4) favourable responses to confidential reference letters from currently licensed "A" trainers or drivers;</li> <li>5. must submit a satisfactory physical and eye examination;</li> <li>6. Receive a recommendation from the examination supervisor and successfully complete the SC practical examination by achieving a passing grade of 75% or better.</li> </ul>			<ul> <li>"F" Trainer licence will permit you to train horses, wholly owned by yourself or an immediate family member, at extended and non extended meetings. The first time applicant for an "F" licence: <ol> <li>must have attained 16 years of age;</li> <li>must have been licensed as an owner by Standardbred Canada or U.S.T.A. for a minimum of one (1) year;</li> <li>must file a recommendation from the panel of regional judges to sit the written examination;</li> <li>must achieve a passing grade of 75% on the written trainer examination;</li> <li>must submit a satisfactory physical and eye examination.</li> </ol> </li> </ul>
